Notification of Source of Distributions Pursuant to Rule 19a-1 under the Investment Company Act of 1940

In connection with the monthly dividend payment of \$0.1106 per share payable on January 2, 2025, to shareholders of record on December 31, 2024, it is anticipated that 20% of such dividend will be a return of capital.
