Notification of Source of Distributions

In connection with the monthly dividend payment of \$0.1107 per share payable on February 3, 2025, to shareholders of record on January 31, 2025, it is anticipated that 30% of such dividend will be a return of capital.

The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes.
