Notification of Source of Distributions

In connection with the quarterly dividend payment of \$0.4675 per share payable on July 1, 2024, to shareholders of record on June 28, 2024, it is anticipated that 39% of such dividend will be a return of capital.

The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes.
